THE PUBLIC CORPORATIONS ACT 1988

(No. 21 of 1988)

- IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 5 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO GUYANA RICE MILLING AND MARKETING AUTHORITY UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOWING ORDER:—
- 1. This order may be cited as the Guyana Rice Milling and Marketing Authority (Vesting of Property) Order 1991 and shall be deemed to have come into operation on 1st March, 1991.

Citation and commencement

2. In this Order —

Interpretation

- (a) "appointed day" means the day on which this Order is deemed to have come into operation;
- (b) "Authority" means the Guyana Rice Milling and Marketing Authority established by the Rice (Regulation of Manufacturing and Marketing) Act 1985, being a body corporate owned by the State.
- The items of immovable property of the State described in the Schedule, and which are at present in the possession of the Authority, are hereby vested in the Authority.
