## MADE UNDER NATIONAL REGISTRATION ACT (19:08)

# IN EXERCISE OF THE POWERS CONFERRED ON THE ELECTIONS COMMISSION BY SECTIONS 6 1 (b), 6 (A), 14 AND 15 OF THE NATIONAL REGISTRATION ACT, Cap 19:08, THE ELECTIONS COMMISSION MAKES THE FOLLOWING ORDER:-

1.	This Order may be cited as the National Registration (Residents) (Revision of Registers) Order 2018.	Citation.
2.	The Registration Officer of every Registration Area in the first Schedule is required to prepare a register of registrants and register of electors for that Registration Area.	Revision of Registers, First Schedule
3.	The qualifying date with reference to which this Order shall applies shall be 31 <sup>st</sup> October, 2018.	Qualifying date.
4.	This Order shall apply to all eligible persons in Guyana who have attained the age of fourteen years.	Applicants
5.	Those persons whose names appear on the Central Register at the coming into operation of this Order may also effect changes/corrections to their particulars and request transfers.	Transactions
6.	The days set out in the second column of the Second schedule shall be the days with reference to which the matters set out in the corresponding entry in the first column thereof shall be done.	Prescribed times for other matters to
