## ORDER

Made Under
THE TRADE ORDINANCE, 1958,
UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, AND BY VIRTUE AND IN EXERCISE OF ALL OTHER POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNORGENERAL AS FOLLOWS:---

1. This Order may be cited as the Trade (Control of Prices) (Amendment) (No. 7) Order, 1968 and shall be construed and read as one with the Trade (Control of Prices) Order, 1963* and any Order amending the same.
2. The first schedule to the Trade (Control of Prices) (Amendment) Order, 1968** is hereby further amended --
(a) by the substitution, for the particulars specified in relation to the number 6 and to the article tomato puree or paste, specificd in the columns of Part A thereof, of the particulars specified in the corresponding columns of Part $A$ of the schedule to this Order;
(b) by the substitution, for the particulars specified in relation to the number 6 and to the article tomato puree or paste, specified in the columns of Part B thereof, of the particulars specified in the corresponding columns of Part B of the schedule to this Order;
(c) by the addition to Part A thereof, of the number 7 and the article carrots, with the particulars set out against them, as specified in Part A of the schedule to this Order; and
(d) by the addition to Part B thereof, of the number 7 and the article carrots, with the particulars set out against them, as specified in Part B of the schedule to this Order.
