THE LOCAL AUTHORITIES (ELECTIONS) ACT, 1969 (No. 23 of 1969)

UNDER SECTION 8(1) OF THE LOCAL AUTHORITIES (ELECTIONS) ACT, 1969, IT IS HEREBY ORDERED BY THE MINISTER AS FOLLOWS:---

1. This Order may be cited as the Local Authorities (Elections) Registration of voters) Order, 1970.

2. The electoral registrar of every local authority area described in the first schedule is hereby required to prepare a register of voters for the local authority area of which he is the electoral registrar.

3. The 30th April, 1970, shall be the qualifying date with reference to which a person shall be qualified to be registered in pursuance of this Order.

4. The days set out in the second column of the second schedule shall be the days with reference to which the matters set out in the first column of the said schedule opposite such days, respectively, shall be done.

FIRST SCHEDULE

Section 2.

1. THE CITY OF GEORGETOWN -

Being all that area comprising the City of Georgetown as provided for by section 7 of the Municipal and District Councils Act, 1969.

2. THE TOWN OF NEW AMSTERDAM -

Being all that area comprising the Town of New Amsterdam as provided for by section 28 of the Municipal and District Councils Act, 1969.

3. THE TOWN OF CHRISTIANBURG/WISMAR/MACKENZIE -

Being all that area compaising the Town of Christianburg/Wismar/ Mackenzie as provided for by section 2 of the Christianburg/Wismar/Mackenzie Town (Constitution) Order, 1970.

4. THE LEGUAN LOCAL GOVERNMENT DISTRICT ----

Being all that area comprising the Leguan Local Government District as provided for by section 2 of the Leguan Local Government District (Constitution) Order, 1970.

5. THE SHEET ANCHOR CUMBERLAND LOCAL GOVERNMENT DISTRICT ---

Being all that area comprising the Sheet Anchor/Cumberland Local Government District as provided for by section 2 of the Sheet Anchor/Cumberland Local Government District (Constitution) Order, 1970.

6. THE BARTICA VILLAGE DISTRICT ---

Being all that area for the time being comprising the Bartica Village District as constituted under the Local Government Ordinance.
