**THE MUNICIPAL AND DISTRICT COUNCILS ACT, 1969.**

(No. 24 of 1969)

**UNDER SECTIONS 325 AND 333 OF THE MUNICIPAL AND DISTRICT COUNCILS ACT, 1969, IT IS HEREBY ORDERED BY THE MINISTER AS FOLLOWS:—**

1. This Order may be cited as the Municipal and District Councils (Transitional Provisions) Order, 1970, and shall come into operation forthwith.
2. The persons specified in the first schedule are hereby appointed to exercise the functions of the Mayor and Town Council of Christianburg/Wismar/Mackenzie until the commencement of the term of office of the first councillors thereof.
3. The persons specified in the second schedule are hereby appointed to exercise the functions of the Leguan District Council until the commencement of the term of office of the first councillors thereof.
4. The persons specified in the third schedule are hereby appointed to exercise the functions of the Sheet Anchor/Cumberland District Council until the commencement of the term of office of the first councillors thereof.
