#### ORDER

#### MADE UNDER

THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE (Chapter 280).

UNDER SECTION 47 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE,

THE COMMISSIONER OF POLICE WITH THE APPROVAL OF THE MINISTER HAD MADE THE FOLLOWING ORDER:—

- 1. This Order may be cited as the Georgetown (One-Way Streets) Order, 1970.
  - 2. (a) No vehicle shall proceed North in or along the roads or the portions thereof mentioned in the first schedule.
    - (b) No vehicle shall proceed South in or along the roads or the portions thereof mentioned in the second schedule.
    - (c) No vehicle shall proceed East in or along the roads or the portions thereof mentioned in the third schedule.
    - (d) No vehicle shall proceed West in or along the roads or the portions thereof mentioned in the fourth schedule.
  - 3. (a) No vehicle shall proceed West from Water Street in or along the road immediately North of the River Police Station.
    - (b) No vehicle shall proceed East in or along the road immediately South of the Georgetown Central Fire Station.
    - (c) No vehicle shall proceed South in or along the road West of the River Police Station.
- 4. The directions and Orders mentioned in the first column of the fifth schedule are hereby revoked to the extent specified respectively in the second column of that schedule.
