

## ORDER

MADE UNDER

## THE TRADE ORDINANCE, 1958

(No. 34 of 1958).

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969\* may be cited as the Trade (Control of Prices) (Amendment) (No. 5) Order, 1971.

2. Part A of the first schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively against the articles of foodstuff numbered, 1 (Butter), 5 (Powdered MILK), 9 (Sardines), 12 (Tomato Paste), 24 (Condensed Milk), 25 (Baby Foods), 26 (Food Beverages), 30 (Pure Lard), 34 (Monosodium Glutamate Seasoning), 36 (Tomato Ketchup), 42 (Chick Peas) and 43 (Rolled Oats), respectively, of the particulars appearing against those numbers, respectively, in the third, fourth and fifth columns, respectively, of Part A of the schedule to this Order.

3. Part B of the first schedule to the Principal Order is hereby amended by the substitution for particulars appearing in the third, fourth and fifth columns, respectively, against the articles of foodstuff numbered, 1 (Butter), 5 (Powdered Milk), 9 (Sardines), 12 (Tomato paste), 24 (Condensed Milk) 25 (Baby Foods), 26 (Food Beverages), 30 (Pure Lard), 34 (Monosodium Glutamate Seasoning), 36 (Tomato Ketchup), 42 (Chick peas) and 43 (Rolled Oats), respectively, of the particulars appearing against those numbers, respectively, in the third, fourth and fifth columns, respectively, of Part B of the schedule to this Order.
