# UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS:—

- 1. This Order which amends the Trade (Control of Prices) (Amenment) Order, 1969,\* may be cited as the Trade (Control of Princes) (Amendment) (No. 7) Order, 1971.
- 2. Part A and Part B of the first schedule to the Principal Order are hereby amended by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively, against the articles of foodstuff numbered 2 (Evaporated Milk) and 5 (Powdered Milk) of the particulars appearing against the articles of foodstuff of those numbers in the third, fourth and fifth columns of Part A and Part B, respectively, of the schedule to this Order.
