THE TRADE ORDINANCE, 1958, (No. 34 of 1958)

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS:-

- 1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969\* may be cited as the Trade (Control of Prices) (Amendment) (No. 12) Order, 1971.
- 2. Part A of the first schedule to the Principal Order is hereby amended -
  - (a) by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively, of that Part against the articles of foodstuff mentioned in the second column thereof and respectively numbered 29 (Cheese), 34(b)(ii) (Monosodium Glutamate Seasoning, Maggi Cubes, case of 40 jars, each jar containing 100 cubes), of the particulars appearing in the third, fourth and fifth columns of Part A of the schedule to this Order against the same articles of foodstuff mentioned in the second column thereof and of the said respective numbers; and

- (b) by the substitution for the particulars appearing in the second, third, fourth and fifth columns, respectively, of that Part against the article of foodstuff mentioned in the second column thereof and numbered (5(b)(iv) (Powdered milk, 50 lb. bag (skimmed)), of the particulars appearing in the second, third, fourth and fifth columns of Part A of the schedule to this Order against the same article of foodstuff mentioned in the second column thereof and of the said number.
- 3. Part B of the first schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the third, fourth and fifth columns, respectively, of that Part against the article of foodstuff mentioned in the second column thereof and numbered 5(b)(iv)(Powdered milk (akimmed)), 29 (Cheese), 34(b)(ii) (Monosodium Glutamate Seasoning, Maggi Cubes, case of 40 jars, each jar containing 100 cubes), of the particulars appearing in the third, fourth and fifth columns, respectively, of Part B of the schedule to this Order against the same articles of foodstuff mentioned in the second column thereof and of the said respective numbers.
