THE TRADE ORDINANCE, 1958

(No. 34 of 1958)

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, I HEREBY
MAKE THE FOLLOWING ORDER :—

1. This Order which amends the Trade (Control of Prices) (Amendment) Order 1969* may be cited as the Trade (Control of Prices) (Amendment) (No. 28) Order, 1971.

2. Part A of the first schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the second, third, fourth and fifth columns, respectively, against the article of foodstuff numbered 12 (Tomato Paste), of the particulars appearing against that number in the second, third, fourth and fifth columns, respectively, of Part A of the schedule to this Order.

3. Part B of the first schedule to the Principal Order is hereby amended by the substitution for the particulars appearing in the second, third, fourth and fifth columns, respectively, against the article of foodstuff number 12 (Tomato Paste), of the particulars appearing against that number in the second, third, fourth and fifth columns, respectively, of Part B of the schedule to this Order.
