THE VALUATION FOR RATING PURPOSES ACT, 1969 (No. 11 of 1969)

UNDER SECTION 4 OF THE VALUATION FOR RATING PURPOSES ACT, 1969, IT IS HEREBY ORDERED AS FOLLOWS:—

- 1. This Order may be cited as the Valuation for Rating Purposes (Preparation of Valuation List) Order, 1972.
- 2. The Chief Valuation Officer is hereby directed to prepare a valuation list for that portion of the City of Georgetown as described in the Schedule.
- 3. The date at which all property in the aforesaid area shall be valued shall be 28th June, 1972.

SCHEDULE

That area commencing at the junction of the projection of the northern extension of Sheriff Street and the northern boundary of Georgetown and extending eastwards along the Atlantic Sea Coast to the eastern boundary of Georgetown, being the eastern boundary of the Company Path on the eastern side of Plantation Cummings Lodge, thence along the eastern boundary of Georgetown to the southern boundary of Georgetown, being the southern boundary of Pln. Rome, thence westwards along the southern boundary of Georgetown to the junction of the canal forming the eastern extremity of the residential areas of the South $\frac{1}{2}$ of Pln. Rome, thence northwards to the Middle Walk Dam of Pln. Rome, thence westwards along the Middle Walk Dam of Pln. Rome to the eastern extremity of the residential areas of the Northern 1 of Pln. Rome and Pln. Houston, thence northwards to Pln. Houston/Ruimveldt side-line dam, thence eastwards along the Pln. Houston/Ruimveldt side-line dam to the proposed Eastern Highway, thence northwards to the Middle Walk Dam of Pln. Ruimveldt, thence westwards along the Ruimveldt Middle Walk Dam to Kitty Avenue, thence northwards along Kitty Avenue to the northern boundary of Pln. La Penitence, thence eastwards along the northern boundary of Pln. La Penitence to its junction

with the proposed Eastern Highway, thence northwards along the proposed Eastern Highway to the Lamaha Canal, thence westwards along the Lamaha Canal to the Middle Walk Dam lying between Lamaha Gardens/Prashad Nagar and Campbellville, thence northwards along the said Middle Walk Dam to its junction with the East Coast railway line, thence westwards along the railway line to its junction with Sheriff Street, thence northwards along Sheriff Street back to the point of commencement, including the areas known
