UNDER SECTION 5 OF THE TRADE ORDINANCE, 1959, I HEREBY MAKE THE FOLLOWING ORDER:---

1. This Order which amends the Trade (Control of Prices) (Amendment) Order 1969* may be cited as the Trade (Control of Prices) (Amendment) (No. 21) Order, 1972.

2.
