THE TRADE ORDINANCE,  
(No. 34 of 1958).

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, I HEREBY  
MAKE THE FOLLOWING ORDER:—

1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969\* may be cited as the Trade (Control of Prices) Amendment) (No. 22) Order 1972.
2. Part A of the first schedule to the Principal Order is hereby amended—
  - (a) in the case of the article of foodstuff mentioned in the second column thereof and numbered 2 (Evaporated Milk) —
    - (i) by the deletion from the second column of the word “Ideal”;
    - (ii) by the insertion in the second column immediately before the words “(b) Brand names other than at (a)”, at the words — “(aa) Ideal”; and the subdivisions set out thereunder;
    - (iii) by the insertion in the third, fourth and fifth columns, re-

spectively, against the words inserted as “(aa) Ideal” of the particulars set out in the third, fourth and fifth columns, respectively, of Part A of the schedule to this Order against the same words in relation to the same article of foodstuff mentioned in the second column thereof and of the said number; and

- (b) in the case of the article of foodstuff mentioned in the second column thereof and numbered 12 (Tomato Paste), by the substitution therein for the particulars appearing in the third, fourth and fifth columns, respectively, against that article of foodstuff and that number, of the particulars appearing in the third, fourth and fifth columns, respectively, of Part A of the schedule to this Order against the same article of foodstuff and of the said number.
3. Part B of the first schedule to the Principal Order is hereby amended—
- (a) in the case of the article of foodstuff mentioned in the second column thereof and numbered 2 (Evaporated Milk) —
    - (i) by the deletion from the second column of the word “Ideal”;
    - (ii) by the insertion in the second column immediately before the words “(b) Brand names other than at (a),” of the words — “(aa) Ideal”, and the subdivisions set out thereunder; —
    - (iii) by the insertion in the third, fourth and fifth columns, respectively, against the words inserted as “(aa) Ideal” of the particulars set out in the third, fourth and fifth columns, respectively, of Part B of the schedule to this Order against the same words in relation to the same article of foodstuff mentioned in the second column thereof and of the said number; and
  - (b) in the case of the article of foodstuff mentioned in the second column thereof and numbered 12 (Tomato Paste) by the substitution therein for the particulars appearing in the third, fourth and fifth columns, respectively, against that article of foodstuff and that number, of the particulars appearing in the third, fourth and fifth columns, respectively, of Part B of the schedule to this Order against the same article of foodstuff and of the said number.
