- (c) by the addition in the second, third, fourth and fifth columns, respectively, thereof to the article of foodstuff mentioned in the second column thereof and numbered 45 (Toilet Soap) of -
 - (i) the subdivision specified in the second column of the schedule to this Order in relation to the article of foodstuff; and
 - (ii) the particulars set out against such subdivisions in the third, fourth and fifth columns, respectively, of Part A of the schedule to this Order.

3. Part B of the first schedule to the Principal Order is hereby amended —

- (a) by the insertion immediately after the words "7 oz.", set out in relation to the brand name "Catelli" appearing in relation to the article of foodstuff numbered 36 (Tomato Ketchup), of the words — "or $7\frac{1}{2}$ oz.";
