## ORDER

## THE CUSTOMS ORDINANCE

(Chapter 309)

UNDER SECTION 8 OF THE CUSTOMS ORDINANCE, I HEREBY  
MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Customs Duties (Carifta Rate) (Amendment) Order 1973 and shall come into operation on the 1st May, 1973.

2. During the continuance in force of this Order the rate of duty set out in the second column of the Schedule against the respective item number specified in the first column thereof shall be payable in lieu of the rate of duty set out as a Carifta rate against the same item number in the column headed "Carifta rate of duty" in Part 1 of the First Schedule to the Ordinance.

3. Part 1 of the First Schedule to the Ordinance is hereby amended in the following respects—

- (a) by the substitution for the particulars appearing in the second column and in the column headed "Carifta Rate of Duty" against item number "112 — 04.11" of the particulars "Cordials and Liqueurs" and the particulars "same as rate of excise duty imposed by the Tax Ordinance", respectively; and
- (b) by the substitution of the words "not being goods entitled to a Carifta rate of duty" for all the words commencing with the word "though" and ending with the word "mentioned".

appearing in paragraphs (2), (3) and (4), respectively, of the proviso to the said Part.
