THE TRADE ORDINANCE, 1958

(No. 34 of 1958)

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS :—

1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969*, may be cited as the Trade (Control of Prices) (Amendment) (No. 17) Order 1973.

2. Part A of the first schedule to the Principal Order is hereby amended by the substitution therein for the particulars in the respective columns in relation to the articles of foodstuff numbered 5 (Powdered Milk) and 42 (Chick Peas), of the particulars in relation to the same articles of foodstuff as set out in the respective columns of Part A of the schedule to this Order.

3. Part B of the first schedule to the Principal Order is hereby amended by the substitution therein for the particulars in the respective columns in relation to the articles of foodstuff numbered 5 (Powdered Milk) and 42 (Chick Peas), of the particulars in relation to the same articles of foodstuff as set out in the respective columns of Part B of the schedule to this Order.
