THE TRADE ORDINANCE, 1958

(No. 34 of 1958)

UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS:—

1. This Order which amends the Trade (Control of Prices) (Amendment) Order, 1969* may be cited as the Trade (Control of Prices) (Amendment) No. 36) Order, 1973.

2. The Principal Order is hereby amended —

- (a) by the substitution in Part A of the First Schedule thereto, for the particulars appearing in the third, fourth and fifth columns, respectively, of that Part against the articles of foodstuff mentioned in the second column thereof, respectively numbered 6 (Pickled beef, other than boneless) and 25 (Baby Foods) of the particulars appearing in the third, fourth and fifth columns, respectively, of Part A of the schedule to this Order against the same articles of foodstuff mentioned in the second column thereof and of the said respective numbers; and
- (b) by the substitution in Part B of the First Schedule thereto, for the particulars appearing in the third, fourth and fifth columns, respectively, of that Part against the articles of foodstuff mentioned in the second column thereof, respectively numbered 6 (Pickled beef, other than boneless), and 25 (Baby Foods), of the particulars appearing in the third, fourth and fifth columns, respectively, of Part B of the schedule to this Order against the same articles of foodstuff mentioned in the second column thereof and of the said respective numbers.
