IN EXERCISE OF THE POWER CONFERRED UPON THE
MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY
ORDER AS FOLLOWS:—

1. This Order, which amends the Trade (Control of Im-^{Citation.}port and Export) Order*, may be cited as the Trade (Control of Import and Export) (Amendment) Order 1974.
