IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY MAKE THE FOLLOWING ORDER:-

- 1. This Order which amends the Trade (Control of Prices) Citation. (Bread) Order 1974 may be cited as the Trade (Control of Prices) (Bread) (Amendment) Order 1975.
 - 2. The Principal Order is hereby amended -

Amendment of the Principal Order.

- (a) by the deletion from clause 4 (1) of the words "offer or expose for sale";
- (b) by the addition thereto of the following clause as clause 6 -
- 6. In any proceedings for an alleged contravention of this Order in respect of the weight of any bread described in the first column of the Schedule, the Court shall disregard the weight of a single loaf of bread but shall have regard to the average weight of six loaves of the same kind (if any) sold by the defendant on the same occasion or offereil or exposed for sale on the same occasion; "and
- by the substitution of the following Schedule as the Schedule thereto -
