1. This Order which amends the Trade (Control of Prices) Order* may be cited as the Trade (Control of Prices) (Amendment) (No. 7) Order 1975.

- (b) by the substitution in Part B of the Fourth Schedule thereto, for the particulars specified in the third, fourth and fifth columns, respectively, in relation to the article numbered 25 (Baby Foods), of the particulars specified in the third, fourth and fifth columns, respectively, of Part B of the Schedule to this Order in relation to the same article and to the said number.
