- 1. This Order which amends the Trade (Control of Prices) Chitathion. Order* may be cited as the Trade (Control of Prices) (Amendment) (No. 15) Order 1975.

- (c) by the substitution in Part B of the Fourth Schedule thereto, for the particulars specified in the third, fourth, and fifth columns respectively in relation to the article numbered 29 (Cheese), of the particulars specified in the third, fourth and fifth columns, respectively, of Part B of the Schedule to this Order in relation to the same article and to the said number.
