IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER
BY SECTION 5 OF THE TRADE ACT, I HEREBY MAKE THE
FOLLOWING ORDER :—

1. This Order which amends the Trade (Control of Prices) Order* may be cited as the Trade (Control of Prices) (Amendment) (No. 35) Order 1975. Citation.

2. The Principal Order is hereby amended —

(a) by the addition to the respective columns of Part A of the Fourth Schedule thereto in relation to the articles respectively numbered (14) Margarine and (15) Lard, of the sub-divisions and particulars relating to those subdivisions specified in the respective columns of Part A of the Schedule to this Order in relation to the same articles and the said numbers; and
