MADE UNDER

THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Chapter 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Fish Processing Plant) Order, 1974* made on the 27th day of May, 1974, the proposed construction of the fish processing plant on the land described in the schedule to that Order was declared to be a public work under section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Chief Works Officer together with his agents, servants or workmen was authorised under section 4 of the Act to enter upon the said land for the purpose of surveying or otherwise examining such land with a view to the acquisition of the whole or a part thereof for the construction of the public work aforesaid;

AND WHEREAS in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer and a plan of the land to be acquired have been laid before the Minister;

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared —

- (i) that the Acquisition of Lands for Public Purposes (Fish Processing Plant) (Plantation Houston) Order 1976** is hereby annulled

(ii) that the land described in the schedule to this Order is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Fish Processing Plant) (Plantation Houston) (No. 2) Order 1976.

SCHEDULE

A tract of land, being part of Plantation Houston, situate on the East Bank of the Demerara River, commencing at a concrete paal marked M.W.H. situate N284° 55' 00" (tr.) and 258.34 ft., from an iron paal HOD, situate at the north-western corner of Lot 'A', and extending thence N15° 16' 10" (tr.) for a distance of 1065.61 ft, to a wooden paal marked K. N. M. thence N104° 25' 55" (tr.) for a distance of 37.74 ft. to a wooden paal marked K. N. M. thence N15° 16' 00" (tr.) for a distance of 321.87 ft. to a wooden paal marked K. N. M. thence N283° 52' 10" (tr.) for a distance of 129.74 ft. thence N196° 16' 22" (tr.) for a distance of 199.99 ft. to a wooden paal marked K. N. M. thence N196° 16' 44" (tr.) for a distance of 432.72 ft. to a wooden paal marked K. N. M. thence N197° 27' 14" (tr.) for a distance of 753.31 ft. to a wooden paal marked K. N. M. thence N193° 26' 05" (tr.) for a distance of 48.81 ft, to a wooden paal marked K. N. M. thence N193° 33' 22" (tr.) for a distance of 194.74 ft. to a wooden paal marked K. N. M. thence N103° 37' 00" (tr.) for a distance of 72.00 ft. to a wooden paal marked K. N. M. thence N12° 49' 00" (tr.) for a distance of 242.00 ft. to a wooden paal marked K. N. M. thence N104° 55' 00" (tr.) for a distance of 62.86 ft. to the concrete mark at the point of commencement. The said tract of land comprises areas "A", "B" and "C" and contains 4.119 acres. It is shown bordered red on a plan by K. N. Maraj, Sworn Land Surveyor, dated 29th March, 1976, on record in the Lands and Surveys Department of the Ministry of Agriculture as plan No. 16885. The said Lot 'A' being shown on a plan by H. O. Durham, Sworn Land Surveyor, dated 10th August, 1922, on record in the Lands Department as Plan No. 2959.
