## ORDER

## MADE UNDER

## THE EMERGENCY POWERS REGULATIONS, 1964

UNDER REGULATION 49 (1) OF THE EMERGENCY POWERS REGULATIONS, 1964 AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING ME IN THAT BEHALF I DO HEREBY ORDER AS FOLLOWS:

1. This Order may be cited as the Emergency Powers (Security of Arms) Order, 1964.

2. In this Order, unless the context otherwise requires —

“appointed period” means the period between 6 a.m. on the 24th day of July 1964 and 6 p.m. on the 27th day of July 1964;

“appointed place” means such place as may be directed by the Commissioner of Police;

“area” means the area set out in the First Schedule hereto;

“arms” means any rifle, shot gun, combined rifle and shot gun and any ammunition therefor in respect of which a firearm licence has been issued;

“exempted person” means a person specified in the Second Schedule hereto;

“firearm licence” means a firearm licence issued under section 18 of the Firearms Ordinance.

(Cap. 345)

3. All persons to whom firearm licences for any arms have been issued shall, if they are resident or present in the area during the appointed period, remove during that period the arms to which such licences relate from the place where they are kept to the appointed places; and all such persons shall, if they enter the area subsequent to the appointed period, forthwith upon entry therein remove such arms from the places where they are kept to the appointed places.

4. The requirements of paragraph 3 of this Order shall not apply to any exempted person.

## FIRST SCHEDULE

## AREA

The portion of the Colony contained within the boundaries of —

- (a) the whole of “A” “C” and “D” Police Divisions;
- (b) that part of “B” Police Division situate to the north of a line drawn from Marabunta Creek on the Corentyne River

to the western boundary of "B" Police Division through a point immediately south of Mara on the Berbice River;

- (c) that part of "E" Police Division situate to the north of a line drawn through a point immediately south of Mackenzie on the Demerara River and extending due east therefrom to the eastern boundary of "E" Police Division and due west therefrom to the western boundary of "E" Police Division.

## SECOND SCHEDULE EXEMPTIONS

1. Persons temporarily within the area whose arms are outside the area and whose firearm licences have been issued outside the area.

2. Persons who have in their employ supernumerary constables appointed under section 84 of the Police Force Ordinance, 1957.

## EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport)

The effect of this Order is to require all persons (other than "exempted persons" listed in the Second Schedule) to remove their licensed rifles, shot guns, combined rifle and shot guns and ammunition (but not pistols or revolvers) between 24th July and 27th July 1964 to such places as the Commissioner of Police may direct.
