

ORDER IN COUNCIL UNDER SECTION 4 OF THE WIDOWS AND ORPHANS PENSION ORDINANCE, 1934 (No. 3 OF 1934) PRESCRIBING TABLES IN THE PLACE OF THE TABLES CONTAINED IN PART I. OF THE SCHEDULE TO THE WIDOWS AND ORPHANS PENSION ORDINANCE, CHAPTER 207.

WHEREAS it is enacted by section 4 (1) of the Widows and Orphans Pension Ordinance, 1934, that the Governor in Council may, with the approval of the Secretary of State, by Order prescribe tables in the place of the tables contained in Part I. of the Schedule to the Widows and Orphans Pension Ordinance, Chapter 207 ;

And whereas it is expedient that new tables should be prescribed in the place of the tables contained in Part I. of the Schedule to the Widows and Orphans Pension Ordinance, Chapter 207 ;

And whereas the Secretary of State has approved of such new tables being prescribed ;

Now, therefore, the Governor in exercise of the powers by the above recited enactment in him vested, by and with the advice of the Executive Council doth hereby order—

- I. That the tables contained in the Schedule to this Order shall be prescribed in the place of the tables contained in Part I. of the Widows and Orphans Pension Ordinance, Chapter 207.
- II. This Order may be cited as the Widows and Orphans Pension Order (No. 2), 1934.
