IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 10 OF THE MINING ACT 1989, I HEREBY MAKE THE FOLLOWING ORDER:-

- Citation. 1. This Order may be cited as the Guyana Geology and Mines Commission (Prospecting and mining for minerals and metals) Reservation Order 2008.
- Reservation. 2. The area hereinafter described in the Schedule below is hereby reserved by the Guyana Geology and Mines Commission for prospecting and mining of minerals and metals but, WITHOUT PREJUDICE to the power of the Minister (as representing the State) to permit any person to carry on in the scheduled area mining or prospecting operations (including operations incidental thereto) for the benefit, wholly or partly, of the Guyana Geology and Mines Commission.

SCHEDULE

A Tract of State Land in the Potaro Mining District No. 2 located on Terra Surveys topographic sheet 44NW.

Commencing at point L. between historical points E and F, with true geographical co-ordinates of latitude 5° 25' 30.9" N, longitude 58° 45' 21.3" W.

Thence at bearing of 259° (T), for a distance of 0.47 miles to Point F, with true geographical co-ordinates of latitude 5° 25' 25" N, longitude 58° 45' 45" W.

Thence at a bearing of 237° 30', for a distance of 1.86 miles to Point G, with true geographical co-ordinates of latitude 5° 25' 03" N, longitude 58° 46' 24" W.

Thence at bearing of 270° (T), crossing an unnamed Left Bank tributary of the Essequibo River, at a point 0.8 miles away from Point G, and covering a total of 1.4 miles to Point H, with true geographical co-ordinates of latitude 5° 25' 03" N, longitude 58° 47' 34" W.


Thence at a bearing of 360° (true) crossing tributaries of the Omai River, and covering a total distance of 4.06 miles to Point I, with true geographical co-ordinates of latitude 5° 28' 31" N, longitude 58° 47' 34" W.

Thence at a bearing of **90° (true)** to the Omai River, for a distance of **1.48 miles** to **Point M**, with true geographical co-ordinates of latitude **5° 28' 30.3" N**, North longitude **58° 46' 18.5" W**.

Thence along the right bank of the Omai River downstream for a distance of **4.55 miles** to **Point N** at the mouth of the Omai River, with the true geographical co-ordinates of **50° 25' 34.5" North** **58° 45' 21.3" West**.

Thence at a bearing of **180° (true)** for a distance of **0.07 miles** to **Point L**, the point of commencement, and containing a total of **3,878 acres** approximately.
