IN EXERCISE OF THE POWERS CONFERRED ON THE ELECTIONS COMMISSION, BY SECTIONS 14A AND 19 OF THE NATIONAL REGISTRATION ACT, Cap. 19:08, THE ELECTIONS COMMISSION MAKES THE FOLLOWING ORDER:-

Citation.

1. This Order may be cited as the National Registration (Residents) (Revision of Registers) Order of 2011.

Revision of Registers, First Schedule.

2. The Registration Officer or Officers of every Registration District mentioned in the First Schedule is required to prepare a register of voters for that Registration District.

Qualifying date.

3. The 30th September, 2011 shall be the qualifying date with reference to which a register of voters shall be compiled in pursuance of this Order.

Prescribed time for other matters to be done. Second Schedule.

4. The days set out in the second column of the Second Schedule shall be the days with reference to which the matters set out in the corresponding entry in the first column thereof shall be done.
