MOTOR VEHICLES AND ROAD TRAFFIC ACT

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 100 (1) (a)  
OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, I MAKE THE  
FOLLOWING ORDER-

Citation 1. This Order may be cited as the Motor Vehicles and Road Traffic  
(International Driving Permits) Order 2011.

International 2. (1) A licensing officer may issue for the use outside of Guyana an  
Driving Permits international driving permit in the Form set out in the Schedule to a person  
who, upon making such application in the prescribed form and paying the  
g officer that he -

- (a) has attained the age of eighteen years;
- (b) holds a valid driver's licence issued in Guyana that does not  
expire for six months;
- (b) is ordinarily resident in Guyana; and
- (c) is competent to drive the motor vehicle of the class or  
description for which the international driving permit is to be  
issued.

(2) An international driving permit issued in accordance with paragraph (1) shall remain in effect for twelve months from the date of issue unless the driver's licence issued in Guyana expires, is revoked or is suspended.

(3) The licensing officer shall enter in a register the particulars of all the holders of international driving permits issued by him.
