IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 5 OF THE TRADE A'CT, I HEREBY MAKE THE FOLLOWING ORDER:—

Citation and commencement,

1. This Order, which amends the Trade (Control of Imports not entitled to Community Rate) Order 1988*, may be cited as the Trade (Control of Imports not entitled to Community Rate) (Amendment) (No. 2) Order 1990 and shall come into operation on 1st November, 1990.

Amendment of the Principal Order.

2. The Principal Order is hereby amended by the substitution, for the Schedule, of the following Schedule -
