THE PUBLI CORPORATIONS ACT 1988

(No. 21 of 1988)

- IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTIONS 3, 4 AND 8 OF THE PUBLIC CORPORATIONS ACT 1988, I HEREBY MAKE THE FOLLOWING ORDER:—
 - 1. This Order may be cited as the Gavana Frequency _{Citation} Management Unit Order 1990.
 - 2. In this Order —

Interpretation

- (a) "concerned Minister" means the Minister assigned the responsibility for the Unit or, where there is no such Minister, the President.
- (b) "Corporation" means the Guyana Telecommunication Corporation established by the Guyana Telecommunication Corporation Order*.
- (c) "Unit means the National Frequency Management Unit established by clause 3.

*Cap. 19:05 Subsidiary Legislation.

Establishment of Guyana Frequency Management Unit,

Functions,

- 3. (1) There is hereby established a public corporation to be known as the National Frequency Management Unit.
 - (2) The Unit shall be a corporation sole, consisting of a managing director, to be appointed by the concerned Minister.
 - (3) In addition to performing the functions conferred upon the corporation sole, the aforesaid managing director shall, in accordance with section 3 (6) of the Act, perform the functions conferred upon the chairman and deputy chairman of a corporation aggregate under the Act.
- 4. (1) The Unit shall perform the functions which were, on the 30th September, 1990, being performed by the Frequency Management Unit of the Corporation.
 - (2) The Minister may, with the consent of the Unit and subject to such conditions as the Minister may specify, appoint the Unit as an agent of the Government for performing any functions relating to the grant of any licence or permission under any written law, including the collection of any licence fees on beha'f of the Government.
 - (3) Without prejudice to the generality of the provisions of paragraphs (1) and (2), functions conferred upon the Unit shall include —
 - (1) long-term radio frequency spectrum management policy and planning;
 - (2) establishment of national radio frequency allocations and regulation of the same;
 - (3) assignment of radio frequencies;
 - (4) licensing and authorisation of the use of radio communications;
 - (5) established of relations with institutions or authorities outside Guyana in the area of radio frequency spectrum management;
 - (6) establishment of technical standards and engineering support facilities necessary or appropriate in relation to the above functions;
 - (7) keeping of records relevant to the performance of its functions;

- (8) inspection of installations related to its functions;
- (9) monitoring the use of the radio frequency spectrum.
- 5. The movable property of the Corporation specified in the Schedule. being movable property which was in use of the Frequency Management Unit of the Corporation on 30th September, 1990, is hereby transferred to the Unit.
- 6. (1) Subject to paragraph (2), the Unit shall continue to employ, on such terms and conditions as may be agreed on between the Unit and him, any person exclusively employed with the Corporation in connection with the Frequency Management Unit of the Corporation immediately before 30th September, 1990, and any person who is so continued in employment by the Unit or who may be employed by the concerned Minister as the managing director of the Unit shall, subject to Section 25 of the Act, be employed on terms and conditions which taken as a whole are no less favourable than those applicable to him, immediately before 30th September, 1990, while he was an employee of the Corporation.
 - (2) The Unit is the successor of the Corporation in the matter of any leave or superannuation rights or benefits (whether earned, accrued, inchoate or contingent) of any such person.
