THE PUBLIC CORPORATIONS ACT 1988

(No. 21 of 1988)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 54 AND 58 OF THE PUBLIC CORPORATIONS ACT 1988, I HEREBY MAKE THE POLLOWING ORDER:—

1. This Order may be cited as the Public Corporations chatton. Secretariat Order 1988.

2. In this Order —

Interpreta-

- (a) "appointed day" means the date on which the Guyana State Corporation stands dissolved;
- (b) "Guyana State Corporation" means the Guyana State Corporation established by section 3 of the Public Corporations Act; Cap, 19:05
- (c) "Secretariat" means the Public Corporations Secretariat established by clause 3.
- 3. With effect from 1st January 1989 there shall be an Establish organisation, which shall be a body corporate with the name ment of Public Corporations Secretariat consisting of the following porations members
 - (a) the Chief Executive Officer of the Secretariat, who shall be the Chairman;
 - (b) the Deputy Chief Executive Officer of the Secretariat who shall be the Deputy Chairman; and
 - (c) the heads of the following divisions of the
 - (i) Planning and Business Development;
 - (ii) Monitoring;

- (iii) Inspectorate; and
- (iv) Enterprise Management.

Functions of Secretariat,

- The functions of the Secretariat shall be
 - (a) to make arrangements to provide Supervisory Councils with officers and other employees required for the performance by them of their functions;
 - (b) to provide the Supervisory Councils and the Minister such other services as may be specified by the Minister (being services which are required or expedient to achieve the objects of the Act); and
 - (c) to perform such other functions as are conferred on it by or under any provision of the Act.

Vesting of property in Secretariat, Schedule

5. The movable and immovable property of the State set out in the Schedule shall vest in the Secretariat.

Dissolution of Guyana State Corporation, Cap, 19:05

6. 31st December 1988 is hereby fixed as the date on which the Guyana State Corporation, established by section 3 of of the Public Corporations Act, shall stand dissolved.

SCHEDULE

PART I — IMMOVABLE PROPERTY

The piece of land known as Lot No. 125, situated at Carmichael Street, Cummingsburg, in the City of Georgetown, in the County of Demerara, Republic of Guyana, save and except the portion which has been transferred to Insurance Brokers Guyana Limited, having the address 125 Carmichael Street, Cummingsburg, by Transport No. 2340 of 1977, with all constructions and erections thereon.

PART II — MOVABLE PROPERTY

All the movable property of the Guyana State Corporation as on the day immediately before the appointed day and which with effect from that day vested in the State, including computers, office equipment, stationery and furniture, account books, documents and other records, motor vehicles, television and other electronic equipment, and cash; sums in accounts maintained by the Guyana State Corporation in banks and debts due to that Corporation.
