THE LOCAL DEMOCRATIC ORGANS ACT 1980

(Act No. 12 of 1980)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 9 AND 50 OF THE LOCAL DEMOCRATIC ORGANS ACT 1980, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order, which amends the Local Democratic Organs (Emoluments of Office-holders) (No. 2) Order 1981*, may be cited as the Local Democratic Organs (Emoluments of Office-holders) (No. 2) (Amendment) Order 1987 and shall be deemed to have come into operation on 1st January, 1986.

Citation and commencement.

2. The Principal Order is hereby amended in the following respects —

Amendment of the Principal Order.

- (a) by the substitution for paragraph (1) of clause 2 of the following paragraph —

“(1) The Mayor of Georgetown shall be paid each month a salary of three thousand and twenty-five dollars, a duty allowance of four hundred dollars and an entertainment allowance of five hundred dollars.”;

- (b) by the substitution in clause 2 (2) for the words “sixteen hundred dollars” of the words “one thousand nine hundred and thirty-six dollars”, and for the full stop of a colon;

- (c) by the insertion after clause 2 of the following proviso —

“Provided that the salary each month for the Mayor and Deputy Mayor of Georgetown for the period that commenced on 1st January, 1985 and ended 31st December, 1985 shall be two thousand two hundred dollars and one thousand seven hundred and sixty dollars respectively.”;

- (d) by the substitution in clause 3 (1) for the words “two thousand six hundred dollars” of the words “three thousand one hundred and forty-six dollars.”;
- (e) by the substitution in clause 3 (2) for the words “one thousand nine hundred and fifty dollars” of the words “two thousand three hundred and sixty dollars”, and for the full stop of a colon.
- (f) by the insertion after clause 3 (2) of the following proviso —

“Provided that the salary each month for the chairman and the vice-chairman for the period that commenced on 1st January, 1985 and ended on 31st December, 1985 shall be two thousand eight hundred and sixty dollars and two thousand one hundred and forty-five dollars respectively.”;

- (g) by the substitution for clause 4 of the following clause —

Deputy
Mayor of

sterdam.**

4. (1) The Mayor of New Amsterdam shall be paid each month a salary of one thousand five hundred dollars, a duty allowance of two hundred dollars and an entertainment allowance of two hundred dollars.

(2) The Deputy Mayor of New Amsterdam shall be paid each month a salary of one thousand dollars, a duty allowance of one hundred and fifty dollars and an entertainment allowance of one hundred and fifty dollars:

Provided that the salary each month for the Mayor and Deputy Mayor of New Amsterdam for the period that commenced on 1st January, 1985 and ended 31st December, 1985 shall be one thousand and seventy-eight dollars and seven hundred and ninety-eight dollars respectively.”.
