**ORDER**

Made Under

**THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT**

(Cap. 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (National Science Research Museum and Recreation Park) Order 1981, No. 28 of 1981 made on the 16th day of December, 1981, the construction of the National Science Research Museum and Recreation Park on the land described in the Schedule to that Order was declared to be a public work under section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Chief Works Officer, together with his agents, servants or workmen, was authorised under section 4 of the Act to enter upon the said land for the purposes therein mentioned;

AND WHEREAS in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer together with a plan of the land to be acquired was laid before the Minister;

AND WHEREAS the Minister has deemed it advisable to declare that the land is required for the public work aforesaid;

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared that the land described in the Schedule to this Order, is required for the public work aforesaid;

This Order may be cited as the Acquisition of Lands for Public Purposes (National Science Research Museum and Recreation Park) Order 1986

#### SCHEDULE

That parcel of land called Block "X" of Area 'AA', being a portion of Chateau Margot, situate on the East Coast of Demerara, in the County of Demerara, Guyana, surveyed and defined on a plan by D. Brijraj, Sworn Land Surveyor, dated 2nd July, 1986, recorded on the 5th August, 1986, at the Department of Lands and Surveys, Georgetown, as Plan No. 21209.

The boundaries of the said Block "X" of Area 'AA', commence at a concrete marker M.W.H. marking the north-eastern corner of the said Block "X" and the Southern boundary of the Public Road Reserve and is situated N 256° 23' 54" (T) at a distance of 140.30 feet from the intersection of the centre lines of the concrete culvert of the east side line trench Plantation Chateau Margot and the Public Road, and extends thence N 291° 21' 12" (T) for 294.36 feet to a concrete marker M.W.H. at the point of tangency of a circular curve, thence along an arc of the said circular curve concave towards the Public Road with the following parameter (degree of curve 00° 19' 12" and central angle 00° 38' 01") for an arc distance of 378.90 feet to a concrete marker M.W.H., thence N 193° 15' 29" (T) for 956.07 feet to a wood paal D.B., thence N 101° 40' 48" (T) for 552.01 feet to a wood paal set in concrete D.B., thence N 13° 39' 33" (T) for 200.01 feet to a wood paal D.B., thence N 101° 43' 55" (T) for 108.49 feet to a wood paal D.B., thence N 13° 39' 24" (T) for 639.40 feet to the concrete marker M.W.H. at the point of commencement, save and except Area "Y" called Chimney Area containing 0.243 acre situated therein and also shown on the aforementioned plan.

The said parcel of land shown on the aforesaid plan, contains an area of 12.915 acres.
