## THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

Citation.

1. This Order, which amends the Trade (Control of Prices) )rder\*, may be cited as the Trade (Control of Prices) (Amendment) (No. 10) Order 1986.

Amendment of the Prin cipal Order.

- 2. The Principal Order is hereby amended as follows
  - (a) by the deletion of the Second Schedule together with the particulars specified in the respective columns of that Schedule in relation to the article numbered 1 (Pickled pork tails);
  - (b) by the deletion of the particulars specified in the respective columns of the Third Schedule in relation to the articles numbered 2 (Fibre boards (not including paperboard) and 3 (Particle board or chip board; all other artificial or reconstituted wood in sheets or in boards; building board of paper or pulp);

- (c) by the deletion of the particulars specified in the respective columns of Parts A and B of the Fourth Schedule in relation to the articles numbered 1 (Butter), 2 (Evaporated milk), 6 (Pickled meat), 3 (Salted fish or salt fish), 9 (Sardines), 12 (Tomato paste), 15 (Lard), 16 (Ghee), 21 (Potatoes), 22 (Garlic) 24 (Condensed milk), 25 (Baby Foods), 26 (Food beverages), 27 (Fruit juice), 28 (Canned soups), 29 (Cheese), 31 (Canned sausages), 32 (Curry Powder), 33 (Instant coffee), 34 (Monosodium Glutamate), 35 (Chocolate bars), 36 (Tomato ketchup), 37 (Jelly crystals), 33 (Icing sugar), 39 (Corned beef), 40 (Canned peas), 41 (Cocoa powder), 42 (Chick peas), 43 (Rolled oats), 45 (Soap (toilet)), excepting items (1) Zohra (m) Lily (n) Nautik (w) Refresh and (x) Medsoap), 46 (Herrings), 47 (Peanut Butter), 49 (Tomato Puree Sunkiss), 58 (Vegetable juices), 59 (Complan), 60 (Punch drink); and
- (d) by the deletion of the particulars specified in the respective columns of Part C of the Fourth Schedule in relation to the article numbered 2 (Batteries).

## EXPLANATORY NOTE

(This is not part of the Order)

This Order decontrols the prices of pickled pork tails, fibre boards, particle board or chipboard, all other artificial or reconstituted wood in sheets or in boards, building board of paper or pulp, butter, evaporated milk, pickled meat, salted lish, sardines, tomato paste, lard, ghee, potatoes, garlic, condensed milk, baby foods, food beverages, fruit juice, canned soups, cheese, canned sausages, curry powder, instant coffee, monosodium glutamate, chocolate bars, tomato ketchup, jelly crystals, icing sugar, corned beef, canned peas, cocoa powder, chick peas, rolled oats, all brands of toilet soap excepting Zohra, Lily, Nautik, Refresh and Medsoap, herrings, peanut butter, tomato puree sunkiss, vegetable juices, complan, punch drink, and batteries.
