THE EMERGENCY ORDER

UNDER SECTION 45 OF THE EMERGENCY ORDER PRE-PARED IN ACCORDANCE WITH SECTION 5 OF THE BRITISH GUIANA (EMERGENCY) ORDER IN COUNCIL, 1953, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

1. This Order may be cited as the Explosive Substances Order, 1954.

2. In this Order—

"County" means a police county the boundaries of which have been defined under section 33 of the Constabulary Ordinance;

"District" means a police district the boundaries of which have been defined under section 33 of the Constabulary Ordinance;

"explosive" has the same meaning as in the Explosives Ordinance.

3. For the purposes of this Order the prescribed authority for any area named in the first column of the First Schedule to this Order shall be the officer specified in the second column opposite the said area

4. (1) No person shall keep or store any explosive except in a secure place approved by the Commissioner of Police.

(2) Any person who keeps or stores, or desires to keep or store any explosives in any place shall notify the Commissioner of Police in writing through the prescribed authority that he keeps or stores, or desires to keep or store explosives in such place.

(3) The Commissioner of Police may, upon the receipt of such notification, cause such place to be examined in order to determine whether such place should be approved by him as a secure place for the keeping or storage of explosives.

5. No person shall carry, convey or use any explosive in any of the areas specified in paragraphs (a), (b), (c), (d), (e), (f) and (g) of the first column of the First Schedule to this Order without the permission in writing of the prescribed authority.

6. (1) The prescribed authority may issue permits for the purchase or acquisition of explosives, and may in such permit specify the nature, the total of explosives which may be purchased or acquired under such permit, the purposes for which the same may be used, and the place where it may be used. Such permit shall be in the Form No. 1 in the Second Schedule to this Order.

(2) A permit issued by a prescribed authority shall be valid for the period therein named, which shall not exceed twelve months, commencing on the date on which it is issued.

7. Permits under section 6 of this Order shall be made in triplicate; one copy shall be retained by the officer who issues it, and two copies shall be delivered to the person to whom it is issued.

(2) Such authority may be issued for one or more such transaction and with respect to a particular kind of explosive, and a particular amount thereof, or may be general and for a period to be therein specified. Such authority shall be in the Form No. 2 in the Second Schedule to this Order.

9. No person shall sell, give, or otherwise permit another person to take from his possession any explosive unless such other person produces a permit in duplicate issued to him under section 6 of this Order, or otherwise than in accordance with the terms of such permit.

10. If the permit has been issued in the Form No. 1 in the Second Schedule to this Order, the person disposing of explosive shall endorse on the two copies the amount so disposed of and his name and address. If the permit is for a limited amount and the total amount of explosives so endorsed by him, or by him and other persons, equals the amount for the purchase and acquisition of which the permit has been issued, he shall retain one copy and forward the same to the prescribed authority who issued it.

11. No person shall purchase or acquire any explosive without having previously obtained a permit to do so under section 6 of this Order, or otherwise than in accordance with the terms of such permit.

12. No person shall use any explosive except for the purposes and at the places specified in the permit issued in respect thereof.

13. (1) A person who has obtained an authority under section 8 of this Order shall cause to be kept books showing the name, address, and description of the persons to whom he disposes of explosive, and the quantity and variety of explosive disposed of to such persons.

(2) Such books shall be open during reasonable hours to the

spection of the Commissioner of Police and other officers of Police not below the rank of Sub-Inspector.

(3) A copy of the entries made during the previous month in such book shall be sent at the commencement of each month to the Commissioner of Police.

14. (1) Nothing in this Order shall be construed to prevent a permit holder from issuing explosives to his workmen, for the use of blasting operations confined to the work controlled by such permit holder; but such permit holder shall enter each day in a book, which he shall keep for that purpose, the amounts and nature of explosives issued by him on such day to such workmen, and such book shall be open to such inspection as in section 13 of this Order mentioned.

(2) In this section —

"workman" shall include a person carrying on blasting by contract in a mine.

15. This Order shall, save as otherwise herein provided, apply to the areas of the Colony specified in the first column of the First Schedule to this Order.
