JNDER SECTION 4 OF THE EXECUTIVE AND LEGISLATIVE COUNCILS (REMUNERATION OF MEMBERS) ORDINANCE, 1953, IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS:—

1. This Order may be cited as the Executive and Legislative Councils

(Remuneration of Members) Order, 1954.

2. The conditions subject to which travelling expenses and subsistence allowances shall be paid to Members of the Executive Council and to Members of the Legislative Council under the provisions of section 4 (1) of the Executive and Legislative Councils (Remuneration of Members) Ordinance, 1953, and the rates at which such payments shall be made shall be as set out in the Schedule to this Order.

3. Payments to be made to Members of the Executive Council and to Members of the Legislative Council under the provisions of section 4 (1) of the Executive and Legislative Councils (Remuneration of Members) Ordinance, 1953, in the manner and at the rates specified in the Schedule to this Order shall be with effect from the 1st January 1954.

SCHEDULE

Part I — Travelling Expenses.

1. Every Unofficial Member of the Executive Council charged by the Governor with the responsibility for any Department or subject:

Commuted travelling allowance of \$120 per month.

- 2. Every Member of the Executive Council not being an Unofficial Member charged by the Governor with the responsibility for any Department or subject:

 Commuted travelling allowance of \$50 per month.
 - 3. Every Member of the Executive Council: Chauffeur allowance not exceeding \$60 per month—subject to the approval of the Governor.
 - The Speaker of the Legislative Council: Commuted travelling allowance of \$50 per month.
- 5. Every Member of the Legislative Council not being the Speaker or a Member of the Executive Council in respect of his attendance at meetings of the Legislative Council or of any committee, board, council or authority appointed by the Governor or the Governor in Council or under powers conferred by any Ordinance and of which he is a member:
 - (a) Travelling allowance at the rate of 26c. per mile for every mile travelled in a car of over 10 h.p.
 - (b) Travelling allowance at the rate of 18c. per mile for every mile travelled in a car of 10 h.p. or under.

Part II — Subsistence Allowances.

Every Member of the Executive Council and every Member of the Legislative Council — in respect of his attendance at meetings of the Executive Council or the Legislative Council or of any committee, board, council or authority appointed by the Governor or the Governor in Council or under powers conferred by any Ordinance and of which he is a Member:

Subsistence Allowance at the rate of \$4.80 per day—subject to the conditions of payment from time to time applying to Members of the Public Service.
