

ORDER IN COUNCIL

MADE UNDER

THE REGISTRATION OF BIRTHS AND DEATHS ORDINANCE,
(Chapter 139).

UNDER SECTION 13 (1) OF THE REGISTRATION OF BIRTHS AND DEATHS ORDINANCE IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS:—

1. This Order may be cited as the Registration of Births and Deaths (Upper Mazaruni Districts) Order, 1954.
2. The districts mentioned in the First Schedule hereto shall be registration districts for the purpose of the Registration of Births and Deaths Ordinance.
3. The boundaries of the said registration districts and the limits of the divisions thereof, shall be as respectively set forth in the Second Schedule hereto.
4. The Order in Council specified in the Third Schedule hereto is hereby revoked to the extent specified therein.
5. This Order shall come into operation on the 1st day of September, 1954.

FIRST SCHEDULE

(Registration Districts)

The Upper Mazaruni No. 1 Registration of Births and Deaths District.
The Upper Mazaruni No. 2 Registration of Births and Deaths District.

SECOND SCHEDULE

(Boundaries of Registration Districts and Limits of the Divisions thereof)

The Upper Mazaruni No. 1 Registration of Births and Deaths District includes that portion of the Colony contained within the following boundaries:—

On the North and West by the watershed between the Mazaruni and Cuyuni rivers; on the South by the Upper Mazaruni No. 2 Registration of Births and Deaths Districts and the watershed between the Mazaruni and Potaro rivers; on the East by a line running north to south from the Tiboku Falls on the Mazaruni River.

Division No. 1 of the Upper Mazaruni No. 1 District includes that portion of the Upper Mazaruni River from and inclusive of Tiboku Falls upwards to and including Peaima Falls and inclusive of all the tributaries of the Mazaruni River.

The Upper Mazaruni No. 2 Registration of Births and Deaths District includes that portion of the Colony contained within the following boundaries:—

On the North by the watershed between the Mazaruni and Cuyuni rivers and a portion of the Upper Mazaruni No. 1 Registration of Births and Deaths District; on the West by the international boundary between Venezuela and British Guiana; on the South by the international boundary between British Guiana and Brazil; on the East by the watershed between the Mazaruni and Potaro rivers.

Division No. 1 of the Upper Mazaruni No. 2 District includes that portion of the Upper Mazaruni River from but exclusive of Peaima Falls to the source of the river, and inclusive of all the tributaries of the Mazaruni River.
