ORDER IN COUNCIL

Made Under THE DRAINAGE AND IRRIGA'TION ORDINANCE, Chapter 102

Chapter 192.

UNDER SECTION 11(1) OF THE DRAINAGE AND IRRIGATION OR-DINANCE, CHAPTER 192, THE FOLLOWING ORDER HAS BEEN MADE BY THE GOVERNOR IN COUNCIL:--

1. The Drainage and Irrigation Board shall ascertain and determine whether the area, or any part thereof, described in the schedule hereto is suitable for and will be benefited by drainage and irrigation or drainage or irrigation.

2. The daily newspapers in which this Order is to be published shall be 'I'he Daily Chronicle and 'The Guiana Graphic.

SCHEDULE

That area of land outside the boundaries of the Zorg-en-Vlygt to Aberdeen and Three Friends to Walton Hall Drainage and Irrigation Areas, and that area of land extending from McNabb to Charity bounded as follows:—

On the North:-- by the Cozier Canal from the Atlantic Ocean to the Pomeroon River.

On the East:--

by the back boundaries of Plantations Johanna Cecelia, Zorg, Golden Fleece, Perseverance, Wastelands, Bremen, Cullen, Abram Zuil, Annandale, Zorg-en-Vlygt, Hoff-Van-Aurich, L'Union, Dageraad, Mocha, Westfield, Alliance from the common boundary between Maria's Lodge and Johanna Cecelia to the common boundary betwen Alliance and Westfield, thence in a straight line to a point on the sand reef forming the south western corner of Crown Land held under Grant No. 2578, thence along the said sand reef lying approximately in a direction N. 14° 15' W (True) to the common boundary between Three Friends and Aberdeen, thence along the sand reef lying approximately in a direction N. 19° W (True) to the junction of the sand reef and the western extremity of the southern boundary of Crown Land held under Licence of Occupancy No. A 1309, thence eastwards along the said southern boundary of Crown Land held under Licence of Occupancy No. A 1309 to its eastern boundary, thence along the said eastern boundary of Crown Land held under Licence of Occupancy No. A 1309 to the northern extremity of the western boundary of Crown Land held under Licence of occupancy No. A 787 and extending eastwards along the northern boundary of the said Licence of Occupancy No. A 787 to the common boundary between Paradise and Walton Hall and thence along the said common boundary between Paradise and Walton Hall to the Atlantic Ocean, thence along the Atlantic Ocean to the eastern extremity of Cozier Canal aforesaid.

by the Pomeroon River commencing from the western extremity of the Cozier Canal aforesaid to a point three hundred feet approximately above Dutchman Creek.

by a line approximately three hundred feet above the junction of the Pomeroon River and Dutchman Creek and parallel to the said Dutchman Creek, and extending to meet and follow the Watershed between Pomeroon River and Tapakuma Lake, Tapakuma River and Capcev River, Tapakuma River and Oena Creek and to encircle the Oena Creek System until it meets the southern extremity of the boundary on the east aforesaid at the Johanna Cecelia/Maria's Lodge sideline.
