## ORDER IN COUNCIL

### Made Under

### THE DRAINAGE AND IRRIGATION ORDINANCE, (Chapter 192).

### UNDER SECTION 11 (1) OF THE DRAINAGE AND IRRIGATION ORDINANCE, THE FOLLOWING ORDER HAS BEEN MADE BY THE GOVERNOR IN COUNCIL --

1. The Drainage and Irrigation Board shall ascertain and determine whether the area, or any part thereof, described in the schedule hereto, or any other area whether including in whole or in part the area aforesaid, is suitable for and will be benefited by drainage and irrigation or drainage or irrigation.

2. The daily newspapers in which this Order is to be published shall be "The Daily Chronicle" and "The Guiana Graphic".

# SCHEDULE

That area at North Klien Poudercyen on the West Bank of the Demerara River in the County of Demerara, the boundaries of which are as follows :--

Commencing at the West Bank of the Demerara River at the south eastern corner of the North Klien Pouderoven Drainage and Irrigation Area and extending thence southwards along the aforesaid West Bank of the Demerara River to its intersection with the prolongation eastwards of the northern boundary of a piece of land containing 3.69 English Acres held by the Colony of British Guiana under Transport No. 1005 dated 28th August, 1928 as shown and laid down on a plan by E. S. E. Parker, Sworn Land Surveyor dated 13th July, 1928, thence westwards along the aforesaid prolongation of and the northern boundary of the aforesaid piece of land to its north western extremity, thence southwards along the line comprising the western boundary of the aforesaid piece of land held under Transport No. 1005 dated 28th of August, 1928, Transport No. 204 dated 9th of March, 1927 and Transport No. 202 dated 9th of March, 1927 to its intersection with the prolongation eastwards of the common boundary between Lot C, Klien Pouderoyen held under Transport No. 240 dated 16th of February, 1948 and North Klien Pouderoyen thence westwards along the aforesaid prolongation of and the common boundary between Lot C. Klien Pouderoven and North Klien Pouderoven aforesaid, to its intersection with the prolongation southwards of the eastern boundary of Lot No. 1 Killarney, North Klien Pouderoven shown and laid down on a plan by D. O. Leila, Sworn Land Surveyor dated 21st March, 1947, thence in a northerly direction along the aforesaid eastern boundary of Lot No. 1 Killarney, North Klién Pouderoven and the prolongation thereof to its intersection with the prolongation westwards of a line parallel to and distant 50 feet north of the northern boundary of Lot C, Shamrock Manor, as shown and laid down on a plan by S. S. N. Insanally, Sworn Land Surveyor dated 6th February, 1930, thence eastwards along the said prolongation, and the line parallel to and distant 50 feet north of the northern boundary of Lot C. Shamrock Manor and its prolongation eastwards to the eastern edge of the trench west of the Public Road thence in a northerly direction along the eastern edge of the trench west of the Public Road to its intersection with that portion of the southern boundary of the North Klien Pouderoven Drainage and Irrigation Area, lying between the eastern edge of the trench west of the Public Road and the West Bank of the Demerara River, thence in an easterly direction along the aforesaid portion of the southern boundary of the North Klien Pouderoyen Drainage and Irrigation Area to the point of commencement.
