ORDER IN COUNCIL MADE UNDER THE DRAINAGE AND IRRIGATION ORDINANCE (Chapter 192).

UNDER SECTION 11 (1) OF THE DRAINAGE AND IRRIGATION ORDIN-ANCE, THE FOLLOWING ORDER HAS BEEN MADE BY THE GOVERNOR IN COUNCIL :—

The Drainage and Irrigation Board shall ascertain and determine whether the area described in the schedule hereto, or any part thereof, or any other area whether including in whole or in part the area described in the schedule hereto is suitable for and will be benefited by drainage and irrigation or drainage or infigation.

SCHEDULE

An area of land commencing at a point on the right bank of the Mahaicony River in the locality known as Mora Point, and being the junction of a line distant 12 feet south of and parallel to the southern dam of the Jugdeo's Canal with the right bank of the Mahaicony River, and proceeding thence in an easterly direction along the aforesaid line distant 12 feet south of and parallel to the southern dam of the Jugdeo's Canal to its junction with the left bank of the Abary River, thence in a southerly direction along the aforesaid left bank of the Abary River to its junction with the southern boundary of the reserve between the tract of land reserved under MP 32/49 and Lease A 3358, thence in a westerly direction along the southern boundary of the reserve between the tract of land reserved under MP 32/49 on the north and Lease A 3358 and Lease A 3391 on the south, to the eastern boundary of the reserve between Lease A 3391 and P 9620, thence in a westerly direction along a straight line to its junction with the southern boundary of the reserve between P 10965 and P 9620 thence in a westerly direction along the aforesaid southern boundary of the reserve between P 10965 and P 9620, to its junction with the eastern boundary of the reserve between P 9620 and Grazing Permission 110/54/104, thence in a westerly direction along a straight line to its junction with the southern boundary of the reserve between P 14169 and Grazing Permission 110/54/104, thence in a westerly direction along the aforesaid southern boundary of the reserve between P 14169 and Grazing Permission 110/54/104 to its junction with the eastern boundary of the reserve between the tract of land reserved under MP 514/59 and Grazing Permission 110/54/104, thence in a westerly direction along a straight line to its junction with the southern boundary of the reserve between P 14480 and the tracts of land reserved under MP 514/59 and MP 83/59/155, thence in a westerly direction along the aforesaid western boundary of the reserve between P 14480 and the tracts of land reserved under MP 514/59 and MP 83/59/155 and its prolongation to its junction with the southern boundary of the reserve between P 16402 on the north and Cattle Grazing Lease 176/58 and the tracts of land reserved under MP 555/54 and MP 1153/56 on the south, thence in a north-westerly direction along the aforesaid southern boundary of the reserve between P 16402 on the north and Cattle Grazing Lease 176/58, and tracts of land reserved under MP 555/54 and MP 1153/56 on the south to its junction with the western boundary of the reserve between P 16402 and Grant 5397 thence in a north-easterly direction along the aforesaid western boundary of the reserve between P 16402 and Grant 5397 to its junction with the common boundary between Lease 1283 and Grant 5397 and thence in a north-westerly direction along the aforesaid common boundary between Lease A 1283 and Grant 5397 and along the common boundaries between Grants 5457 and 4025 on the north and Grants 5397 and 4033 on the south to the right bank of the Mahaicony River, thence in a northerly direction along the right bank of the Mahaicony River back to the point of commencement.
