## ORDER IN COUNCIL

MADE UNDER

## THE WORKMEN'S COMPENSATION ORDINANCE

(Chapter 111)

UNDER SUBSECTION (1) OF SECTION 23 OF THE WORKMEN'S COMPENSATION ORDINANCE, IT IS HEREBY ORDERED BY THE GOVERNOR IN COUNCIL AS FOLLOWS:—

1. This Order may be cited as the Workmen's Compensation (Compulsory Insurance) Order, 1960.
2. Subsection (1) of section 23 of the Workmen's Compensation Ordinance shall apply to the employment specified in the schedule hereto in addition to the employments to which it already applies.
3. This Order shall come into operation on the 1st June, 1960.

## SCHEDULE

Any employment connected with any of the following—

- (a) the manufacture of rice including all the processes known as soaking, steaming, drying, hulling and bagging;
- (b) the manufacture of matches, or the mixing of chemical materials for making matches or any process incidental to the making of matches;
- (c) the manufacture or adaption for sale of tobacco in any form;
- (d) the printing of patterns in colours upon paper either by blocks affixed by hand, or by rollers worked by mechanical power;
- (e) the manufacture of bricks, tiles or other building materials;
- (f) the operation of any railway, including work on construction reconstruction, maintenance, repair or demolition of rollingstock of all description;
- (g) the operation, maintenance, or repair of machinery used for purposes of draining or irrigating agricultural lands;
- (h) the treatment by mechanical or chemical processes of minerals extracted from the earth;
- (i) the generation or transformation or distribution of electrical energy for the purpose of the supply thereof by way of trade, or for the purpose of lighting any street, public place or public building, or any hotel, railway, mine or other industrial undertaking;
- (j) the cultivation, harvesting or transportation of sugar cane;
- (k) the preparation and transportation by land or water of all ligneous forest products;
- (l) the operation of any craft, whether propelled by machinery or not, on any inland waterway;

- (m) the extraction of rock from surface excavations or the crushing of stone;
- (n) the mechanical cultivation, harvesting or transportation of rice;
- (o) the felling of trees or the squaring or hauling of timber;
- (p) the handling and transportation of scrap iron;
- (q) the stacking of sugar or rice in bags;
- (r) the using of machinery moved by mechanical power in any category of employment below mentioned whether such machinery is used directly or indirectly in any part of the process thereof, or in the promotion or maintenance of the same—
  - (i) the manufacture of aerated waters of any kind;
  - (ii) the manufacture of beer and other malt liquors;
  - (iii) the making of bread or biscuits;
  - (iv) the manufacture of edible oil or soap;
  - (v) the manufacture of margarine and butter;
  - (vi) the manufacture of ice;
  - (vii) the manufacture and handling of gases;
  - (viii) the slaughter of animals for food and the preparation of the flesh of such animals for sale;
  - (ix) the supply of water for drinking or domestic purposes;
  - (x) the manufacture of food for livestock;
  - (xi) the manufacture, alteration or repair of articles of clothing, including boots and shoes;
  - (xii) the manufacture of leather or the preparation of the hides or skins of animals for purposes of trade;
  - (xiii) the manufacture, alteration or repair of machinery or of any article of metal not being machinery;
  - (xiv) the construction, reconstruction, maintenance, repair or demolition of ships, boats or vessels;
  - (xv) the removal and disposal of sewage or the destruction of refuse;
  - (xvi) the process of letter-press, printing, or bookbinding;
  - (xvii) the manufacture of fibre.
