THE INTERPRETATION AND GENERAL CLAUSE ACT

(Cap. 2:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 27 OF THE INTERPRETATION AND GENERAL CLAUSES ACT, AND ALL OTHER POWERS ENABLING ME IN THAT BEHALF, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Delegation of Functions to Minister of State within the Ministry of Finance Order, 1983.

2. I hereby delegate Cde. H.L.B. Singh, Minister of State within the Ministry of Finance, to exercise on my behalf the function referred to in column (2) of the Schedule and conferred upon me by the written law referred to in the corresponding entry in column (1) thereof.

3. Notwithstanding anything contained in this Order, the functions delegated by me to Cde. H.L.B. Singh by this Order shall not include the delegation of the power to make subsidiary legislation or to hear any appeal.
