ORDER

MADE UNDER

THE BRITISH GUIANA (CONSTITUTION) ORDER IN COUNCIL, 1961.

WHEREAS it is provided by paragraph (1) of article 21 of the Constitution of British Guiana that the Governor acting with the concurrence of the Premier may, from time to time, by order published in the Gazette, prescribe the offices that are to constitute the personal staff of the Governor, the salaries and allowances that are to be paid to the members of the personal staff of the Governor, and the other sums that are to be paid in respect of expenditure attaching to the office of the Governor;

AND WHEREAS it is provided by subsection (1) of section 4 of the British Guiana (Constitution) Order in Council, 1961, that at any time after the said section comes into operation and before the appointed date, the Governor, acting with the concurrence of the senior Nominated Unofficial Member of the Executive Council, may, by order published in the Gazette, prescribe in relation to the first Governor under the Constitution any matter which falls to be prescribed by an order made in pursuance of paragraph (1) of article 21 of the Constitution:

NOW, THEREFORE, I, acting with the concurrence of the senior Nominated Unofficial Member of the Executive Council, do hereby prescribe in relation to the first Governor under the Constitution, that the offices set out in the first column of Part I of the Schedule hereto shall constitute the personal staff of the Governor, and that the salaries and allowances set out in the second and third columns of Part I of the said Schedule, shall be the annual salaries and allowances that are to be paid to the respective members of the personal staff of the Governor, and further, that the sums set out in Part II of the said Schedule shall be the other annual sums that are to be paid in respect of the expenditure attaching to the office of Governor.
