THE CONSUMPTION TAX ACT

(Cap. 80:02)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 4 OF THE CONSUMPTION TAX ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order, which amends the Consumption Tax Order*, ^{Citation} may be cited as the Consumption Tax (Amendment) Order 1981, and shall be deemed to have come into operation on 20th February, 1981.

2. The Principal Order is hereby amended —

(a) by the substitution of the particulars specified in the Schedule hereto for the corresponding particulars specified in the schedule thereto;

(b) by the deletion of the ad valorem tax imposed by the Consumption Tax (Amendment Order 1980)** on those goods specified in the Schedule hereto on which that tax was imposed.
