IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

Citation, - 1. This Order, which amends the Trade (Control of Prices) Order*, may be cited as the Trade (Control of Prices) (Amendment) (No. 10) Order 1981.
