Citation.

1. This Order, which amends the Trade (Control of Prices) Order*, may be cited as the Trade (Control of Prices) (Amendment) (No. 2) Order 1985.

- (d) by the substitution of the particulars specified in Part B of Schedule II to this Order for the corresponding particulars specified in the respective columns of Part B of the Fourth Schedule thereto.
