THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This Order, which amends the 'Trade (Control of Prices) Order*', may be cited as the Trade (Control of Prices) (Amendment) (No. 15) Order 1985. ^{Citation.}

2. The Principal Order is hereby amended as follows — ^{Amendment of the Principal Order.}
