THE LEGISLATURE (REMUNERATION OF MEMBERS) ORDINANCE, 1962,

(No. 1 of 1962).

UNDER SECTION 6 OF THE LEGISLATURE (REMUNERATION OF MEM-BERS) ORDINANCE, 1962, IT IS HEREBY ORDERED BY THE MIN-ISTER OF FINANCE AS FOLLOWS:—

1. This Order may be cited as the Legislature (Remuneration of Members) Order, 1962.

2. In this Order —

"the Ordinance" means the Legislature (Remuneration of Members) Ordinance, 1962.

3. The travelling and subsistence allowances to be prescribed for the purposes of section 6 of the Ordinance and the conditions subject to which they shall be payable, shall be as set out in the schedule hereto.

SCHEDULE

1. The Premier and every other Minister charged by the Governor with responsibility for any department or subject, shall be paid —

- (a) a commuted travelling allowance of \$120 per month;
- (b) a chauffeur allowance not exceeding \$90 per month, subject to the approval of the Premier in the case of every other Minister.
- 2. The Speaker of the Legislative Assembly, shall be paid -
- (a) a commuted travelling allowance of \$65 per month;
- (b) a chauffeur allowance not exceeding \$60 per month;
- 3. The President of the Senate shall be paid -
- (a) a commuted travelling allowance of \$65 per month;
- (b) a chauffeur allowance not exceeding \$60 per month.
- 4. Every Parliamentary Secretary shall be paid a commuted travelling allowance of \$120 per month.
- 5. Every member of a chamber of the Legislature (other than the Premier, a Minister or a Parliamentary Secretary or the Speaker of the Legislative Assembly or the President of the Senate) in respect of his attendance at meetings of the chamber of the Legislature of which he is a member, or of any committee, board, council or authority appointed by the Governor or under powers conferred by any Ordinance and of which he is a member shall be paid —

- (a) travelling allowance at the rate of 28 cents per mile for every mile travelled in a car of over 12 h.p. owned by him and certified by him to that effect;
- (b) travelling allowance at the rate of $19\frac{1}{2}$ cents per mile for every mile travelled in a car of 12 h.p. or under owned by him and certified by him to that effect;
- (c) actual travelling expenses incurred where he is obliged to travel by other means of transport as a result of the area from which he is required to travel to attend meetings aforesaid not being served by transport services operated by the Transport and Harbours Department.
- 6. Every member of a chamber of the Legislature shall be entitled to travel at the expense of the Government by transport services operated by the Transport and Harbours Department.
- - Every member of a chamber of the Legislature in respect of his attendance at meetings of the chamber of the Legislature of which he is a member, or of any committee, board, council or authority appointed by the Governor or under powers conferred by any Ordinance and of which he is a member, shall be paid subsistence allowance at the rate of \$4.80 per day or actual expenses subject to the conditions of payment from time to time applying to officers in the public service.
