ORDER

THE INTERPRETATION ORDINANCE,

(Chapter 5).

UNDER SECTION 40 OF THE INTERPRETATION ORDINANCE, IN ACCORDANCE WITH PARAGRAPH (1) OF ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

1. This Order may be cited as the Delegation of Powers (Miscellaneous Provisions) Order, 1962.

2. The Minister charged with responsibility for Sea Defences and Drainage and Irrigation is hereby deputed to exercise on behalf of the Governor the powers specified in the first column of the schedule to this Order conferred on the Governor by the Ordinances mentioned in the second column of the said schedule, subject however to the following conditions and qualifications —

- (a) that the delegation of each power effected by this Order shall remain in force until it is varied or revoked by the Governor;
- (b) that the exercise of any power delegated by this Order shall be subject to any direction either general or particular, which the Governor may from time to time give in that respect.

1. To appoint any member of the Sea Defence Board.	The Sea Defence Ordinance, Chapter 191. (Section 4 (1) ).
2. To revoke the appointment of any appointed member of the Sea Defence Board.	The Sea Defence Ordinance, Chapter 191. (Section 4 (7) ).
3. To approve the appointment of the Secretary of the Sea Defence Board.	The Sea Defence Ordinance, Chapter 191. (Section 5 (1) ).
4. To nominate two members of the Drainage and Irrigation Board from members of village councils.	The Drainage and Irrigation Ordinance, Chapter 192. (Paragraph (b) of subsection (1) of section 4).

| 8. To approve the appointment of the Secretary of the Drainage and Irrigation Board.  | The Drainage and Irrigation Ordinance, Chapter 192. (The proviso to section 5).                     |
