THE INTERPRETATION ORDINANCE,

(Chapter 5).

UNDER SECTION 40 OF THE INTERPRETATION ORDINANCE, IN AC-CORDANCE WITH PARAGRAPH (1) OF ARTICLE 22 OF THE CON-STITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXER-CISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:—

1. This Order may be cited as the Delegation of Powers (Miscellaneous Provisions) Order, 1962.

2. The Minister charged with responsibility for Sea Defences and Drainage and Irrigation is hereby deputed to exercise on behalf of the Governor the powers specified in the first column of the schedule to this Order conferred on the Governor by the Ordinances mentioned in the second column of the said schedule, subject however to the following conditions and qualifications —

- (a) that the delegation of each power effected by this Order shall remain in force until it is varied or revoked by the Governor;
- (b) that the exercise of any power delegated by this Order shall be subject to any direction either general or particular, which the Governor may from time to time give in that respect.
